AN ACT

AMENDING SECTION 17-306, ARIZONA REVISED STATUTES; AMENDING TITLE 17, CHAPTER 3, ARTICLE 1, ARIZONA REVISED STATUTES, BY ADDING SECTION 17-321; RELATING TO DANGEROUS WILDLIFE.

1 Be it enacted by the Legislature of the State of Arizona:

2 Section 1. Section 17-306, Arizona Revised Statutes, is amended to
3 read:

4 17-306. Importation, transportation, release or possession of
5 live wildlife

6 ~~No~~ A person shall NOT import or transport into ~~the~~ THIS state, ~~or~~ sell,
7 trade or release within ~~the~~ THIS state or ~~have in his possession~~ POSSESS any
8 live wildlife except as authorized by the commission, AS PROVIDED BY SECTION
9 17-321 or as defined in title 3, chapter 16.

10 Sec. 2. Title 17, chapter 3, article 1, Arizona Revised Statutes, is
11 amended by adding section 17-321, to read:

12 17-321. Possession of dangerous wildlife prohibited;
13 exceptions; violation; classification; definition

14 A. EXCEPT AS PROVIDED IN SUBSECTION B OF THIS SECTION, A PERSON SHALL
15 NOT OWN, POSSESS, KEEP, HARBOR, IMPORT OR TRANSPORT INTO THIS STATE, HAVE
16 CUSTODY OR CONTROL OF OR PROPAGATE DANGEROUS WILDLIFE.

17 B. SUBSECTION A OF THIS SECTION DOES NOT APPLY TO A PERSON IN LAWFUL
18 POSSESSION OF DANGEROUS WILDLIFE BEFORE JULY 1, 2010. A PERSON IN POSSESSION
19 OF DANGEROUS WILDLIFE HAS THE BURDEN OF PROVING THE PERSON LAWFULLY POSSESSED
20 THE DANGEROUS WILDLIFE BEFORE JULY 1, 2010. A PERSON WHO LAWFULLY POSSESSED
21 DANGEROUS WILDLIFE BEFORE JULY 1, 2010 MAY RETAIN POSSESSION OF THAT
22 DANGEROUS WILDLIFE FOR THE REMAINDER OF THE ANIMAL'S LIFE BUT ONLY IF THE
23 PERSON COMPLIES WITH ALL OF THE FOLLOWING REQUIREMENTS:

24 1. MAINTAINS COMPLETE AND ACCURATE VETERINARY RECORDS FOR THE
25 DANGEROUS WILDLIFE, INCLUDING IMMUNIZATION RECORDS.

26 2. MAINTAINS ALL DOCUMENTS AND RECORDS ESTABLISHING THAT THE PERSON
27 POSSESSED THE ANIMAL BEFORE JULY 1, 2010.

28 3. PRESENTS THE DOCUMENTARY EVIDENCE TO A GAME RANGER, WILDLIFE
29 MANAGER OR PEACE OFFICER ON REQUEST.

30 4. NOTIFIES THE DEPARTMENT WITHIN TWO DAYS AFTER ANY BITE OR INJURY
31 THE ANIMAL CAUSES TO ANY PERSON THAT REQUIRES MEDICAL ATTENTION.

32 C. A GAME RANGER, WILDLIFE MANAGER OR PEACE OFFICER MAY SEIZE
33 DANGEROUS WILDLIFE IN ANY OF THE FOLLOWING CIRCUMSTANCES:

34 1. THE SEIZING OFFICER HAS PROBABLE CAUSE TO BELIEVE THAT THE ANIMAL
35 WAS ACQUIRED ON OR AFTER JULY 1, 2010 IN VIOLATION OF THIS SECTION.

36 2. THE WILDLIFE POSES A RISK TO PUBLIC SAFETY OR HEALTH.

37 3. THE WILDLIFE IS IN POOR HEALTH AND CONDITION AS A RESULT OF THE
38 POSSESSION.

39 4. THE WILDLIFE IS HELD IN VIOLATION OF THIS SECTION.

40 D. IF DANGEROUS WILDLIFE IS SEIZED PURSUANT TO THIS SECTION, THE OWNER
41 IS RESPONSIBLE FOR:

42 1. THE REASONABLE COSTS OF CARING AND PROVIDING FOR THE WILDLIFE
43 DURING THE SEIZURE.

44 2. ESTABLISHING ANY RIGHT TO RECOVER THE WILDLIFE. A PERSON MAY
45 RECLAIM DANGEROUS WILDLIFE THAT HAS BEEN SEIZED UNDER THIS SECTION ONLY BY

1 ESTABLISHING THAT THE POSSESSION COMPLIES WITH THE CONDITIONS AND
2 REQUIREMENTS OF THIS CHAPTER.

3 E. IF DANGEROUS WILDLIFE THAT IS SEIZED PURSUANT TO THIS SECTION IS
4 NOT RETURNED TO THE PERSON ORIGINALLY IN POSSESSION, THE GAME RANGER,
5 WILDLIFE MANAGER OR PEACE OFFICER MAY RELEASE THE WILDLIFE TO AN INSTITUTION
6 OR ENTITY LISTED UNDER SUBSECTION F OF THIS SECTION. IF THE GAME RANGER,
7 WILDLIFE MANAGER OR PEACE OFFICER CANNOT RELOCATE THE WILDLIFE WITHIN A
8 REASONABLE PERIOD OF TIME, AS DETERMINED BY THE GAME RANGER, WILDLIFE MANAGER
9 OR PEACE OFFICER, THE WILDLIFE MAY BE EUTHANIZED.

10 F. THIS SECTION DOES NOT APPLY TO WILDLIFE IN THE LAWFUL POSSESSION
11 OF:

12 1. INSTITUTIONS ACCREDITED OR CERTIFIED BY A NATIONAL ASSOCIATION OF
13 ZOOS AND AQUARIUMS OR A FACILITY WITH A CURRENT SIGNED MEMORANDUM OF
14 PARTICIPATION WITH AN ASSOCIATION OF ZOOS AND AQUARIUMS SPECIES SURVIVAL
15 PLAN.

16 2. INCORPORATED NONPROFIT ANIMAL PROTECTION ORGANIZATIONS, SUCH AS
17 HUMANE SOCIETIES AND SHELTERS, HOUSING AN ANIMAL AT THE WRITTEN REQUEST OF
18 THE DEPARTMENT OR ACTING UNDER THE AUTHORITY OF THIS CHAPTER.

19 3. LOCAL ANIMAL CONTROL AUTHORITIES ACTING UNDER THE AUTHORITY OF THIS
20 CHAPTER.

21 4. VETERINARY HOSPITALS OR CLINICS.

22 5. A RESEARCH FACILITY AS DEFINED BY THE ANIMAL WELFARE ACT OF 1970
23 (7 UNITED STATES CODE SECTION 2131) FOR THE SPECIES OF ANIMALS FOR WHICH THEY
24 ARE REGISTERED, INCLUDING UNIVERSITIES, COLLEGES AND LABORATORIES HOLDING A
25 VALID CLASS R LICENSE UNDER THE ANIMAL WELFARE ACT.

26 6. CIRCUSES, DEFINED AS INCORPORATED CLASS C LICENSEES UNDER THE
27 ANIMAL WELFARE ACT OF 1970 (7 UNITED STATES CODE SECTION 2131), THAT ARE
28 TEMPORARILY IN THIS STATE AND THAT OFFER PERFORMANCES BY LIVE ANIMALS, CLOWNS
29 AND ACROBATS FOR PUBLIC ENTERTAINMENT.

30 7. A PERSON TEMPORARILY TRANSPORTING AND DISPLAYING DANGEROUS WILDLIFE
31 THROUGH THIS STATE IF THE TRANSIT TIME IS NOT MORE THAN SEVEN DAYS AND THE
32 ANIMAL IS MAINTAINED AT ALL TIMES WITHIN A CONFINEMENT SUFFICIENT TO PREVENT
33 THE ANIMAL FROM ESCAPING.

34 8. A NONPROFIT ORGANIZATION OPERATING A WILDLIFE SANCTUARY THAT CARES
35 FOR ANIMALS, INCLUDING DANGEROUS WILDLIFE AND WHERE:

36 (a) NO ACTIVITY IS CONDUCTED THAT IS NOT IN THE ANIMAL'S NATURAL
37 HABITAT OR INHERENT TO THE ANIMAL'S NATURE OR NATURAL CONDUCT.

38 (b) NO COMMERCIAL ACTIVITY INVOLVING AN ANIMAL OCCURS INCLUDING:

39 (i) THE SALE OR TRADE IN ANIMALS, ANIMAL PARTS, ANIMAL BYPRODUCTS OR
40 ANIMAL OFFSPRING.

41 (ii) THE SALE OF PHOTOGRAPHIC OPPORTUNITIES INVOLVING AN ANIMAL.

42 (iii) THE USE OF AN ANIMAL FOR ANY TYPE OF ENTERTAINMENT.

43 (c) NO ANIMAL BREEDING OCCURS IN THE FACILITY.

44 G. IN ADDITION TO SEIZURE OF THE DANGEROUS WILDLIFE, A PERSON WHO
45 VIOLATES THIS SECTION IS GUILTY OF A CLASS 2 MISDEMEANOR.

- 1 H. A CITY, TOWN OR COUNTY MAY ADOPT AN ORDINANCE GOVERNING DANGEROUS
2 WILDLIFE THAT IS MORE RESTRICTIVE THAN THIS SECTION, BUT A CITY, TOWN OR
3 COUNTY IS NOT REQUIRED TO ADOPT ANY ORDINANCE TO COMPLY WITH THIS SECTION.
- 4 I. NOTHING IN THIS SECTION AFFECTS THE AUTHORITY OF THE COMMISSION
5 UNDER SECTION 17-306.
- 6 J. THE COMMISSION MAY ADOPT RULES IN COMPLIANCE WITH THIS SECTION.
- 7 K. FOR THE PURPOSES OF THIS SECTION, "DANGEROUS WILDLIFE" MEANS THE
8 FOLLOWING ANIMALS AND ALL HYBRIDS, WHETHER BRED IN THE WILD OR IN CAPTIVITY:
- 9 1. ALL SPECIES OF THE GENUS DIDELPHIS. COMMON NAME: AMERICAN
10 OPOSSUMS.
- 11 2. ALL SPECIES OF THE ORDER INSECTIVORA. COMMON NAMES INCLUDE:
12 INSECTIVORES, SHREWS, HEDGEHOGS, TENRECS, SOLENODONTS AND MOLES.
- 13 3. ALL SPECIES OF THE ORDER CHIROPTERA. COMMON NAME: BATS.

10 Sec. 3. Finding; purpose

11 A. The legislature finds that personal possession of dangerous
12 wildlife as pets poses a threat to public health and safety and the health of
13 the wildlife population in this state.

14 B. The purpose of this act is to protect the public health and safety
15 and the health of the wildlife population in this state from dangerous
16 wildlife held as pets.
